The Manager – Analytics will work across asset classes and investment strategies to assist with analysis, research, portfolio construction and risk management. S/he will lead the Analytics Team, supporting the Partnership Management Team and Portfolio Management Team.

Summary of responsibilities:

- Develop and maintain data infrastructure to deliver analytics on asset allocation, portfolio risk, and performance across entire portfolio. Build interactive dashboards and customized investment reports for the investment team's use in ongoing management of the portfolios.
- Coordinate with the operations and investment teams to ensure accurate accounting and performance data is maintained in the portfolio management system as well as document underlying positions and investment exposures.
- Automate the analysis of existing and potential investments using a variety of performance and risk measurement techniques. Document processes.
